MINNESOTA SALES TAX

Sales Tax 7.375%
(Applied to Gas, Electric, Minnkota Wind Surcharge, and Commercial and Industrial Water charges. NOTE: Residential Water is tax exempt.)

Seasonal Sales Tax 7.375% May - Oct

Seasonal Sales Tax 0.000% Nov - Apr

(In accordance with state law, gas or electric usage is tax-exempt for Residential properties when it is claimed as the main source of heat in a home - listed as "Seasonal Sales Tax.")

What is a Facility Charge?

A Facility Charge is the cost to have the service brought to the meter and ready to be used when needed. This charge covers the system maintenance and improvements to provide dependable service.

What is a Usage Charge?

This is the cost for the actual metered utility (electric, gas, or water) that you have consumed. Sanitary Sewer has usage based off of the metered water.
